- 1 Raw material for Pipes, Tubes & 'U' Tubes must be offered for inspection along with Certificate in Form III-A / III-B / IV of IBR – 1950 with mill test certificates if procured from Well Known Steel Pipe / Tube maker's as per IBR – 1950 before commencement of manufacturing.
- 2 Drawings of 'U' Tubes must be got approved from the under signed as per Regulation 395 of IBR – 1950 before starting manufacturing.
- 3 Physical / Mechanical tests and Eddy Current testing of Pipes, Tubes & 'U' Tubes must be done in presence of the Competent Person, in your In-house approved Laboratory. All machines must have valid calibration failing which testing will not be allowed in in-house laboratory.
- 4 Chemical tests of samples of Pipes, Tubes & 'U' Tubes must be done in presence of the Competent Person in the Laboratory approved by this office.
- 5 Other Non-Destructive tests like Micro, Macro, UT, IGC, MPI, PMI etc. of Pipes, Tubes & 'U' Tubes must be done as per the requirements of Material Specifications / IBR – 1950 in the Laboratory approved by this office or by recognized NDT Agency.
- 6 Construction and workmanship must be in accordance with the Indian Boiler Regulations – 1950 and to the satisfaction of the Competent Person or Inspecting Authority.
- 7 You shall have to carry out manufacturing of Pipes, Tubes & 'U' Tubes as per instructions issued from time to time either by Competent Person or Inspecting Authority.
- 8 This approval/ recognition can be withdrawn at any time without giving notice if the workmanship is not found satisfactory as per IBR – 1950.
- 9 You will have to inform this office immediately if there is any change in existing name of the Company / Existing Technical Staff of the Company.
- 10 You will have to employ sufficient technical staff to the satisfaction of the Inspecting Authority time to time.
- 11 You are hereby instructed to get it renewed before 60 days from the expire of this certificate.
